Regarding quality, environment, health and safety

- 3. Process optimization within the organization and ensuring the necessary resources to achieve the established objectives.

- 6. Continuous improvement and development of the Integrated Management System and the quality of products (software products, web applications, etc.) and IT services.
- 7. Continuous compliance with legal requirements and other requirements to which the organization subscribes regarding environmental protection and health and safety.
- 8. Providing the necessary infrastructure and work environment for the proper conduct of all processes, considering H&SE approach

- 10. Pollution prevention through rational use of resources and reducing environmental impact upon environmental factors such as water, air, soil, noise, by waste & resource reduction, reuse & recycling, usage of the energy in an efficient way (including reusable), adequate/limited usage of chemical substances
- 11. Prevention of injuries and professional illnesses of staff, including ensuring: (1) the necessary personal protective equipment, where applicable; (2) the proper usage of handling chemical substances; (3) dedicated training to personnel with different H&SE subjects, such as machine safety, according to the context and the applicable legislation in this domain
- 12. Ensure emergency preparedness for the organization (such as fire prevention, etc.), by training and appropriate testing
- 13. Elimination as much as possible of workplace hazards and reduction of health and safety risks at work, implicitly work incidents and accidents; the applicable target is "zero accidents"
- 14. Staff participation and consultation regarding health and safety at work as well as significant environmental aspects
- 15. Continuous training and motivation of all staff to improve professional knowledge, as well as the responsible and conscious involvement of all in achieving good quality products (software products, web applications, IT services, etc.) / services executed, to comply with internal regulations, Integrated Management System requirements, and job-related tasks.

We aim to achieve these objectives by implementing, maintaining, and continuously improving the Integrated Management System. Compliance with the provisions of the integrated management system documents, applicable legal requirements, and standard requirements is mandatory for all organization personnel.

The quality, environmental, health and safety policy is communicated to all employees, and the level of understanding is evaluated during internal audits.
